## ANNUAL BUDGET AND APPROPRIATION ORDINANCE OF THE VILLAGE OF FISHER FOR THE FISCAL YEAR BEGINNING MAY 1, 2020 AND ENDING APRIL 30, 2021

An ordinance making appropriations for the corporate purposes of the VILLAGE OF FISHER, ILLINOIS, for the fiscal year commencing on the first day of May 1, 2020 and ending on April 30, 2021.

WHEREAS, the Village of Fisher, Champaign County, Illinois (the "Village") is a duly organized and existing municipal corporation created under the provisions of the laws of the State of Illinois and under the provisions of the Illinois Municipal Code, as from time to time supplemented and amended; and

**WHEREAS**, pursuant to 65 ILCS 5/8-2-9 the Village of Fisher is required to annually adopt an Appropriation Ordinance in the first quarter of its fiscal year; and

**WHEREAS**, the fiscal year for the Village of Fisher begins the first day of May and ends the last day of April each year; and

#### WHEREAS:

A. The Village of Fisher anticipates the following revenues for the Fiscal year commencing May 1, 2020 and ending April 30, 2021:

B. The Village of Fisher anticipates certain expenses associated with the business of the Village and miscellaneous revenues which should bridge any difference between expenses and income.

NOW THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the VILLAGE OF FISHER, CHAMPAIGN COUNTY, ILLINOIS:

#### **SECTION 1:**

That the above recitals are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in its entirety.

#### **SECTION 2:**

That the amounts hereinafter set forth, or so much thereof, as may be authorized by law, or may be needed or deemed necessary to defray all expenses and liabilities of the Village, be and the same are hereby approved and appropriated for such Corporate objects and purposes and such other funds herein describe for the fiscal year beginning May 1, 2020 and ending April 30, 2021, together with the Certificate of Estimated Revenues by source anticipated to be received by the Village for said fiscal year.

#### **SECTION 3:**

The appropriations herein made for any purpose shall be regarded as only maximum amounts to be expended under the respective appropriation accounts and shall not be construed as a commitment, agreement, obligation, or liability of the Village or Corporate Authorities. Any positions not separately established or authorized by action of the Corporate Authorities shall not be funded solely by virtue of the adoption of this Ordinance. No employee, officer or agent shall have the right to demand continuous employment and compensation by reason of any appropriation, if it becomes necessary to discharge, eliminate or reduce the number of hours worked for a position or employee on account of lack of work or funds. In the case of a vacancy in any office or position herein, the vacancy shall not be required to be filed, if it is so deemed in the judgment and sole discretion of the Corporate Authorities. No monies shall be expended over the amount stated for a corporate object or purpose without prior approval of the Corporate Authorities.

## **SECTION 4:**

That any unexpended balances of the appropriations for the fiscal years prior hereto are hereby specifically re appropriated for the same general purpose for which they were originally made and may be expended in making up any insufficiency in any item or items provided in this Ordinance. Wherever herein an appropriation is made for a legally binding commitment arising under a prior year appropriation, the amount appropriated herein is a re appropriation of the unexpended balance, not an increase in the amount previously appropriated and such amount remains subject to prior approval by the Corporate Authorities before expenditure.

## **SECTION 5:**

The following sums, or so much thereof as may be authorized by law, be and the same are hereby appropriated for the corporate purposes of the VILLAGE OF FISHER, ILLINOIS, to defray all necessary expenses and liabilities of said VILLAGE OF FISHER, ILLINOIS, as hereinafter specified for the fiscal year commencing on the first day of May, 2020 and ending on April 30, 2021 to-wit:

## **SECTION 6:**

In anticipation of maintaining capital improvement reserves for unanticipated and planned capital projects in the future, the Village maintains a reserve account with an approximate balance of \$6,500,000.00 for which it hereby appropriates the sum of \$6,500,000.00 to be designated as a separate account hereby referenced as the "Future Capital Project Fund" with these reserves being in addition to any other foregoing revenue and the within appropriated amount being in addition to any of the foregoing appropriations.

#### **SECTION 7:**

The said several sums of money are hereby appropriated from monies received and to be received by the VILLAGE OF FISHER, from all sources, and nothing set forth herein shall prohibit transfers from one Village fund to another provided such monies are disbursed in compliance with law, this ordinance and subsequent tax levies. The appropriations herein made for any purpose shall be regarded only as maximum amounts to be expended under the respective appropriation accounts and shall not be construed as a commitment, agreement, obligation, or liability of the Village and each appropriation shall be subject to further approval as to the expenditure thereof by the Corporate authorities of the Village.

## **SECTION 8:**

If any item or portion thereof of this Ordinance is for any reason invalid, such decision shall not affect the validity of the remaining portion of such item or the remaining portion of this Ordinance, as this Ordinance, and its parts, are declared to be severable and any section, clause, provision, or portion of this Ordinance that is declared invalid shall not affect the validity of any other provision of this Ordinance, which shall remain in full force and effect.

## **SECTION 9:**

That the Village Clerk is hereby authorized and directed to publish this Ordinance in pamphlet form
